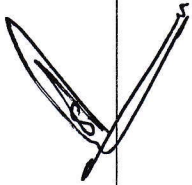


NOTIFICATION

It is notified for information and necessary action of all concerned that the Board of Governors (BoG) in its 116th meeting held on 28-12-2022 approved the following amendments in Examination Rules:

EXISTING RULE	APPROVED AMENDMENT
1.16 Examination of Additional Subjects a. A candidate after one year of passing HSSC-II examination or an examination recognized as equivalent thereto, may appear in additional subject of Mathematics or Biology in current course not offered by him previously.	1.16 Examination of Additional Subjects a. A candidate after passing SSC/HSSC examination or an examination recognized as equivalent thereto, may appear in any additional subject(s) in current course not offered by him/her previously. If a candidate intends to appear in the subject(s) involves practical, proof of performing the relevant practical will be provided to the Board.
1.16, b(5) A candidate failing in additional subject shall not be allowed the 2 nd attempt.	1.16, b(5) In case of additional subject(s) a candidate may avail two attempts to pass paper(s)/improve marks/result.
9.2 Improvement Certificate(s) a. If a candidate succeeded in improving his/her marks, a certificate showing the improved grade/marks shall be issued to him/her on surrendering previous certificate. In case original certificate is lost/burnt etc, he/she shall apply for issuance of duplicate certificate (as per clause 9.4-a) along with prescribed fee.	9.2 Improvement Certificate(s) a. If a candidate succeeded in improving his/her marks, a certificate showing the improved grade/marks shall be issued to him/her after depositing prescribed fee.

<p>9.3 Revised Certificates(s)</p> <p>a. For issuance of revised certificates following documents shall be provided:</p> <p>i. Application/Covering letter;</p> <p>ii. Certificate to be corrected (in original); and</p> <p>iii. Correction letter issued by the Board</p> <p>c. Original certificate shall be surrendered for issuance of revised certificate. In case original certificate is lost/burnt etc, he/she shall submit an affidavit for the lost of previous certificate along with prescribed fee meant for duplicate certificate.</p>	<p>9.3 Revised Certificates(s)</p> <p>a. For issuance of revised certificates following documents shall be provided:</p> <p>i. Application/Covering letter;</p> <p>ii. Correction letter issued by the Board;</p> <p>c. May be omitted.</p>
