2. The following categories of students will be eligible to appear in HSSC 02nd Annual Examination 2022:

- All the registered candidates of HSSC I & II up to April, 2022 (Regular/Ex/Private) whose admission form was not submitted/cancelled for HSSC 1st Annual Examination 2022, due to any reason are eligible to apply for HSSC 02nd Annual Examination 2022.
- All those registered candidates of HSSC I & II up to April, 2022 who submitted their admission form for HSSC 1st Annual Examination 2022 but remained full absent/Compartment candidates for any reason are eligible to apply for HSSC 02nd Annual Examination 2022.
- The candidates who intend to improve their Grade/Marks after passing HSSC Examination can do so by re-appearing in any number of subjects/papers of their own choice in the current course/syllabus and model paper as per notified by the FBISE are eligible to apply which is available at FBISE site.
- The students of HSSC I & II 1st Annual Examination 2022 who remained absent / compartment, candidates can reappear in HSSC 2nd Annual Examination 2022.
- IBCC candidates are eligible to appear in HSSC 2nd Annual Examination 2022.
- Passed candidates of HSSC Part-I 1st Annual Examination 2022 can appear for improving the marks/grade.
- Change of subjects/group will not be allowed under any circumstances after final submission of the online admission form to the FBISE's site.
- All the Heads of affiliated institutions are requested to ensure that the particulars of candidates on the admission forms are recorded on the basis of registration cards. Admission form(s) will not be entertained/accepted without registration number(s).

3. **MODE OF SUBMISSION FOR REGULAR CANDIDATES OF HSSC-I& II.**

Admission data (in soft form) placed on FBISE website for HSSC-I & II candidates will be filled in letter and spirit by the institution within given due dates. **No hard/printed copy of admission form of HSSC- I & II regular candidates shall be submitted by institution(s).** Principal concerned shall attach a certificate that the student (s) of Orphan/disable is a regular candidate.

4. **MODE OF REMITTANCE OF FEE**

For remittance of fee to the FBISE account, the overseas institutions/candidate(s) may exercise one of the following options:-

- i. The payment may be made through Credit Card (Master or Visa) from FBISE website.
- ii. The payment may be made through SWIFT "MT-103" (via Commercial channel instead of home remittance (PRI) for credit into **FBISE Pak Rupee Account Swift Code: HABBPCCA IBAN Code No. PK26HABB 0022 1100 5000 2001** at the Habib Bank Limited, FBISE branch, Sector H-8/4, Islamabad (Pakistan), (Nature of fee must be mentioned while preparing Swift MT 103 form/text) OR FBISE US dollar account (IBAN) **PK 79 HABB 0022 1179 0068 7511** (for US dollar remittance only) at Habib Bank Limited, FBISE Branch, H-8/4, Islamabad.
- iii. Payment may also be made through **Bank Draft drawn able at Islamabad (Pakistan)** issued in the favour of Controller of Examinations, Federal Board of Intermediate & Secondary Education, Islamabad.
- iv. The institutions/candidates forwarding admission forms from KSA and UAE may remit the dues/examination fee through following banks to HBL, FBISE account:-
