## 2. The following categories of students will be eligible to appear in HSSC 02<sup>nd</sup> Annual Examination 2022: -

- i. All the registered candidates of HSSC I & II up to April,2022 (Regular/Ex/Private) whose admission form was not submitted/cancelled for HSSC 1st Annual Examination 2022, due to any reason are eligible to apply for HSSC 02nd Annual Examination 2022.
- ii. All those registered candidates of HSSC I & II up to April, 2022 who submitted their admission form for HSSC 1st Annual Examination 2022 but remained full absent/Compartment candidates for any reason are eligible to apply for HSSC 02nd Annual Examination 2022.
- iii. The candidates who intend to improve their Grade/Marks after passing HSSC Examination can do so by re-appearing in any number of subjects/papers of their own choice in the current course/syllabus and model paper as per notified by the FBISE are eligible to apply which is available at FBISE site.
- iv. The students of HSSC I & II 1st Annual Examination 2022 who remained absent / compartment, candidates can reappear in HSSC 2<sup>nd</sup> Annual Examination 2022.
- v. IBCC candidates are eligible to appear in HSSC 2<sup>nd</sup> Annual Examination 2022.
- vi. Passed candidates of HSSC Part-I 1st Annual Examination 2022 can appear for improving the marks/grade.
- vii. Change of subjects/group will not be allowed under any circumstances after final submission of the online admission form to the FBISE's site.
- viii. All the Heads of affiliated institutions are requested to ensure that the particulars of candidates on the admission forms are recorded on the basis of registration cards. Admission form(s) will not be entertained/accepted without registration number(s).
- ix. Admission fee shall be remitted at any nearest Habib Bank Limited (HBL), Muslim Commercial Bank (MCB) Branches by completing/downloading fee challan available at FBISE, website. Challah number shall be mentioned on online admission form. The Scanned copy of the remittance through easy paisa along with auto system generated fee challan must be attached with online admission form. Without fee deposited or paid after the due date, admission form (s) of concerned student/institution will not be entertained.

No hard/printed copy of admission form and documents (if any) of HSSC-I & II regular candidates shall be submitted by institution(s). Principal concerned shall attach scanned copy of certificate that the student (s) Orphan/disable/FBISE Employees is a regular candidate.

4. MODE OF SUBMISSION FOR EX/REGISTRED PRIVATE/IMPROVEMENT/IBCC CANDIDATES.

Admission data (in soft form) placed on FBISE website i.e. <a href="www.fbise.educ.pk">www.fbise.educ.pk</a> will be filled in letter and spirit and submitted online by the candidates within given due dates. No hard/printed copy of admission form and documents (if any) shall be sent by the candidate to FBISE office by post.
