NOTIFICATION

It is notified for information of all concerned that the National Curriculum 2022 for the subject of Islamiyat Compulsory stands implemented at SSC level from the current academic session 2023-25 and onwards. Thereby, the students of current Class-IX and subsequently to be promoted to Class-X in 2024, shall be examined from the Students Learning Outcomes (SLOs) of National Curriculum 2022 of Islamiyat Compulsory in SSC Part-I Examination 2024 and SSC Part-II Examination 2025 respectively.

- 2. For further clarification, following is the detail:
 - i. All the students from Federal Directorate of Education (FDE) and those who opted National Curriculum 2022 in Class-IX Annual Examination 2023, will be examined in Class-X Annual Examination 2024 from the National Curriculum 2022.
 - ii. All those students who appeared in the old Curriculum (2002) in the Class-IX Annual Examination 2023 will accordingly appear in the old Curriculum (2002)/old course in their Class-X Examination 2024.
 - iii. For SSC Second Annual Examination 2023, the students will appear in the same Curriculum in which they already appeared in their First Annual Examination 2023 including those who staggered their subjects in the First Annual Examination 2023.
 - iv. No textbook is prescribed for Curriculum 2022. The Books published by National Book Foundation and Punjab Curriculum and Textbook Board are recommended/suggested as reference material. However, the students, teachers and other stakeholders may further broaden their studies by relying on any other authentic source duly approved by respective authorities while preparing for the examination.
 - v. The question papers will be based on the SLOs of the National Curriculum 2022. However, for questions related to the translation of the Holy Quran, the following Surahs will be included for FBISE Summative Examination:

vi. All the schools will ensure teaching of the complete required translation of the Surahs as per the Curriculum. The Surahs other than those mentioned above, will be assessed at the school level.

- vii. The questions from the above mentioned Surahs will be of understanding nature. No question regarding translation of any word from the Verses and Hadiths or translation of Verse/Hadith from one language to another language will be given in the question paper.
- viii. Updated model question papers both for Class-IX and Class-X based on the Students Learning Outcomes (SLOs) of National Curriculum 2022 as per the above mentioned policy guidelines will be issued shortly. However, model papers for the old Curriculum 2002 will remain in practice till SSC Second Annual Examination 2024.
