**NOTIFICATION FOR HSSC SPECIAL ANNUAL EXAMINATION 2020**

It is hereby notified for the general information of all concerned that the Higher Secondary School Certificate (HSSC) Special Annual Examination, 2020 of the Federal Board of Intermediate and Secondary Education, Islamabad, shall commence with effect from Tuesday, 20<sup>th</sup> October 2020.

2. The last date for receipt of admission forms/list in the Board's Office is 20<sup>th</sup> August, 2020.

**NOTE:-**

- i. Those institutions/candidates who mail/post their admission forms/lists to the Board must dispatch them at least three days before the last date specified above to avoid rejection of admission form(s).
- ii. All those regular and ex/private candidates who are not satisfied by their HSSC-II result (Annual Examination 2020) are eligible to apply in the HSSC special Annual Examination 2020 after getting their Results cancelled. No exam fee shall be charged.
- iii. All the heads of affiliated institutions are requested to ensure that the particulars of candidates on the admission forms are recorded on the basis of registration cards Admission list will not be entertained / accepted without registration number(s).
- iv. The institutions and Ex-Private candidates of Gilgit-Baltistan (Gilgit / Skardu) should submit their admission forms/lists to FBISE's Sub-Offices Gilgit & Skardu, as per schedule.
- v. No fresh candidate is allowed to appear in Special Annual Examination 2020.
- vi. The candidates (Improvement & Compartment) having their last chance to appear in exam are eligible to apply on separate form placed on FBISE website along with prescribed fee and schedule for submission of admission forms, as per detail below:-.

The relevant field(s) of Admission form (in soft form) placed on FBISE website for candidates will be filled in letter and spirit by the institution within given due dates. **No hard copy of admission form of HSSC-II regular candidates shall be submitted by institution(s).** Institutions shall only forward the computerized generated list of candidates including candidate name, registration numbers, Roll No(s) of HSSC Annual Examination 2020, covering letter duly signed and stamped by Principal along with original result cards of candidates of HSSC Annual Examination 2020 for cancellation within given due dates to the Controller of Examinations (Conduct) by post or at One window cell (OWC) of FBISE. 4. MODE OF SUBMISSION FOR EX/PRIVATE CANDIDATES:-

The Ex-private candidates of HSSC-II who have been issued result card of Annual Examination 2020 and are not satisfied by their result of HSSC Annual Examination 2020 should fill in only the required fields in the online admission form available on FBISE website [www.fbise.edu.pk](http://www.fbise.edu.pk) and submit the hard copy of computerized admission form within give due dates along with original result card of HSSC Annual Examination 2020 for cancellation to the Controller of Examinations (Conduct) by post or at One Window Cell of FBISE. These admission forms will not require any attestation.

5. MODE OF SUBMISSION FOR CANDIDATES (IMPROVEMENT AND COMPARTMENT CASES) HAVING THEIR LAST CHANCES.

All Those Ex/Private candidates who have last chance at their end will appear in FBISE Examination 2020 in compartment/improvement subject/paper(s) and apply via online admission forms placed on FBISE website and furnish hard / Printed copy of the same along with fee Challan/transaction details within due dates as given in Para-2 (vi). The Ex/Private candidates of HSSC-II who have been issued result cards of Annual Examination 2020 are not eligible to apply for this category.
