5. The pre-printed Computerized Admission Forms of failure Regular/Ex/Private candidates of HSSC Annual Examination, 2019 are being sent to the Heads of Institutions/Centre's concerned who will issue the same to the failure candidates along with their Result Cards.

Candidates failing at HSSC Annual Examination 2019, (compartment cases) who receive the pre-printed Computerized Admission Forms shall sign the Admission Form, write the postal address & contact number, deposit the required fee, and submit to the Board. These forms will not require any attestation. However, those candidates who do not receive Computerized Admission Forms shall download computerized admission forms from FBISE Website i.e. www.fbise.edu.pk.


7. **NO FRESH CANDIDATE IS ALLOWED TO APPEAR IN SUPPLEMENTARY EXAMINATIONS.** However, those candidates who intend to improve their Grade/Marks or want to take exam in Additional Subject(s) are eligible to appear in Supplementary Examination. Admission Form can be obtained from the Board's office or can be downloaded from FBISE Website i.e. www.fbise.edu.pk.

8. Those candidates whose result is declared late by the Board, may submit their Admission Forms with normal fee within 15 days from the date of declaration of their result but before commencement of the Examination.
