- 5. For remittance of fee in US Dollars to the FBISE, the overseas candidates may exercise one of the following options:
 - a. Payment may be made through Bank Draft drawnable at Islamabad (Pakistan) issued in favour of the Controller of Examinations (Conduct), Federal Board of Intermediate & Secondary Education, Islamabad. Any Bank Draft/Electronic Transfer in foreign currency, drawnable in a foreign country (other than Pakistan) will not be accepted at any cost.
 - b. The amount may be remitted through SWIFT "MT-103" with clear reference of purpose in "field 70". For credit to FBISE Account No. ((IBAN) PK 79 HABB 0022 1179 0068 7511 at Habib Bank Limited, FBISE Branch, H-8/4, Islamabad (Pakistan).

- 7. The compartmental candidates of SSC Annual Examination, 2018, who receive the pre-printed Computerized Admission Form shall sign the Admission Form, deposit the required fee, enter the Bank Draft Number/SWIFT transaction reference at the given place and sent the same to the Controller of Examinations (Conduct) by post/by bag. However, those candidates who do not receive Computerized Admission Form shall download Computerized Admission Form from FBISE web-site i.e. www.fbise.edu.pk and shall sign the Admission Form, deposit the required fee, enter the Bank Draft Number/SWIFT transaction reference at the given place and send the same to the Controller of Examinations (Conduct) by post/by bag. These forms will not require any attestation.
- 8. Those candidates whose result is declared late by the Board may submit their Admission Forms with normal fee within 15 days from the date of declaration of their result but before commencement of the Examination.

FOR IMPROVEMENT CASES:-

9. The candidates who intend to improve their Grade/Marks after passing SSC Examination can do so by re-appearing in any number of subjects/papers of their choice or Part-I or Part-II or both the Parts/entire examination as the case may be within a period of one year of passing the relevant examination. The candidates appearing in any subject (both the papers) involving practical examination shall appear in the practical examination as well. However, candidate neither require nor can appear in practical if he/she is appearing in a paper of a subject or any one part of the examination. The candidates should fill in the Admission forms which can be downloaded from FBISE web-site i.e. www.fbise.edu.pk, and send the admission form along with prescribed fee to Controller of Examinations (Conduct) by post/by bag.
