It is hereby notified for the general information of all concerned that the **SECONDARY SCHOOL CERTIFICATE (SSC) SUPPLEMENTARY EXAMINATION, 2019** of the Federal Board of Intermediate and Secondary Education, Islamabad will be held with effect from **Wednesday, the 04th September 2019**.

2. The schedule for receipt of Admission Forms along with Admission Fee in the Board Office is as under:-

NOTE:

- The candidates should ensure that their admission form(s) along with prescribed fee should reach the Board's office on or before the last date specified above to avoid payment of extra fee or rejection of form(s).
 - A candidate appearing in any subject(s)/paper(s) will pay full fee of his/her respective part/group.
 - No fresh candidate is allowed to appear in supplementary examination
 - Those candidates whose result is declared late by the Board may submit their Admission Forms with normal fee within 15 days from the date of declaration of their result but before commencement of the Examination.
3. The pre-printed Computerized Admission Forms bearing scanned photographs of failure Regular, Ex/Private candidates of SSC Annual Examinations, 2019 are being sent to the Heads of Institutions/Centres concerned who will issue the same to the failure candidates along with their Result Cards.
4. The compartmental candidates of SSC Annual Examination, 2019, who receive the pre-printed Computerized Admission Form shall sign the Admission Form, deposit the required fee, enter the Bank Draft Number/SWIFT transaction reference at the given place and sent the hard copy of admission form along with requisite original Bank Draft/swift transfer receipt (**Board's Copy**) to the Controller of Examinations (Conduct) by post/by bag. However, those candidates who do not receive Computerized Admission Form shall download Computerized Admission Form from FBISE web-site i.e. www.fbise.edu.pk and shall sign the Admission Form, deposit the required fee, enter the Bank Draft Number/SWIFT transaction reference at the given place and sent the same to the Controller of Examinations (Conduct) by post/by bag. These forms will not require any attestation.

5. **MODE OF SUBMISSION FOR IBCC AND IMPROVEMENT CANDIDATES:-**

The candidates who intend to improve their Grade/Marks after passing SSC Examination can do so by re-appearing in any number of subjects/papers of their choice or Part-I or Part-II or both the Parts/entire examination as the case may be within a period of one year of passing the relevant examination. The candidates appearing in any subject (both the papers) involving practical examination shall appear in the practical examination as well. However, candidate neither require nor can appear in practical if he/she is appearing in a paper of a subject or any one part of the examination. The candidates should fill in the Admission Form which can be obtained from the Board's office free of cost or can be downloaded from FBISE web-site i.e. www.fbise.edu.pk and sent the hard copy of admission form along with requisite original Bank Draft/swift transfer receipt (**FBISE Copy**) to the Controller of Examinations (Conduct) by bag/by post. Admission form of non-registered IBCC candidates must be got attested from Head of an affiliated institution. Only non-registered IBCC candidates have to paste two (02) photographs on prescribed places at page 01 of the admission form (01 un-attested and whereas second one must be got cross attested)

6. MODE OF REMITTANCE OF FEE.

For remittance of fee to the FBISE account, the overseas candidate(s) may exercise one of the following options:-

- i. The payment may be made through SWIFT "MT-103" purpose in for credit into FBISE Pak Rupee Account Swift Code: HABBPCCA IBAN Code No. PK26HABB 0022 1100 5000 2001 at the Habib Bank Limited, FBISE Branch, Sector H-8/4, Islamabad (Pakistan), (Nature of fee must be mentioned while preparing Swift MT 103 form/text) OR FBISE US dollar account (IBAN) PK 79 HABB 0022 1179 0068 7511 (for US dollar remittance only) at Habib Bank Limited, FBISE Branch, H-8/4, Islamabad.
- ii. Payment may be made through Bank Draft drawnable at Islamabad (Pakistan) issued in favour of Controller of Examinations (Conduct), Federal Board of Intermediate & Secondary Education, Islamabad. Any Bank Draft/Electronic Transfer in foreign currency, drawnable in a foreign country (other than Pakistan) will not be accepted at any cost.
- iii. Payment may be made through Credit Card (Master or Visa) from FBISE website.
- iv. The candidates forwarding admission forms from KSA and UAE may remit the dues/examination fee through following banks to HBL, FBISE account:-
