It is hereby notified for general information of all concerned that the **SECONDARY SCHOOL CERTIFICATE (SSC) SUPPLEMENTARY EXAMINATION, 2019** of the Federal Board of Intermediate and Secondary Education, Islamabad will commence with effect from **Wednesday, the 04th September 2019**.

2. The schedule for receipt of Admission Forms along with Admission Fee in the Board Office is as under:-

NOTE:

- The candidates should ensure that their admission form(s) along with prescribed fee should reach the Board's office on or before the last date specified above to avoid payment of extra fee or rejection of form(s).
 - A candidate appearing in any subject(s)/paper(s) will pay full fee of his/her respective part/group.
 - No fresh candidate is allowed to appear in supplementary examination.
 - Those candidates whose result is declared late by the Board may submit their Admission Form with normal fee within 15 days from the date of declaration of their result but before commencement of the Examination.
 - The candidates of Gilgit, Baltistan (Gilgit/Skardu) should submit their admission forms to FBISE's Sub Office, Gilgit & Skardu, Baltistan as per admission schedule.
 - Admission Fee shall be remitted at any nearest branch of Habib Bank Ltd. (within Pakistan) through computerized Bank challan slip which is being sent along with Computerized Admission Forms. However, it can also be downloaded from FBISE web site i.e. www.fbise.edu.pk. Original Board copy of fee challan must be sent to Board's office along with admission form within specified due dates.
3. The pre-printed Computerized Admission Forms bearing scanned photographs of failure regular candidates of SSC Annual Examination, 2019 are being sent to the Heads of Institutions concerned who will issue the same to the candidates along with their Result Card. The pre-printed Computerized Admission Forms of the Ex/Private failure candidates are being dispatched on their addresses given by them in their Admission Forms.
4. The compartmental candidates of SSC Annual Examination, 2019, who receive the pre-printed Computerized Admission Forms shall sign the Admission Form, deposit the required fee, enter Challan Number at the given place and submit the same within given due dates to the Controller of Examinations (Conduct) by post or at One Window Cell of FBISE. **However, those candidates who do not receive Computerized Admission Form shall download Computerized Admission Form from FBISE web-site i.e. www.fbise.edu.pk and shall sign the Admission Form, deposit the required fee, enter Challan Number at the given place and submit the hard copy of admission form along with original challan receipt (Board's Copy) within given due dates to the Controller of the Examinations (Conduct) by post or at One Window Cell of FBISE. These forms will not require any attestation.**


5. MODE OF SUBMISSION FOR IBCC AND IMPROVEMENT CANDIDATES:-

The candidates who intend to improve their Grade/Marks after passing SSC Examination can do so by re-appearing in any number of subjects/papers of their choice or Part-I or Part-II or both the Parts/entire examination as the case may be within a period of one year of passing the relevant examination. The candidates appearing in any subject (both the papers) involving practical examination shall appear in the practical examination as well. However, candidate neither require nor can appear in practical if he/she is appearing in a paper of a subject or any one part of the examination. The candidates should fill in the Admission Form which can be obtained from the Board's office free of cost or can be downloaded from FBISE web-site i.e. www.fbise.edu.pk and submit the admission form along with requisite original challan receipt (Board's Copy) within given due dates to the Controller of Examinations (Conduct) by post or at One Window Cell of FBISE. Admission Form of non-registered IBCC candidates must be got attested from any of the Government Officer of BPS-17 and above in Education Department/Officers of Armed Force/Heads of an affiliated institution. Only non-registered IBCC candidates have to paste two (02) passport size photographs on prescribed place at page I of the admission form (One un-attested whereas second one must be got cross attested)
